

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the <http://www.odemgroup.com> and ODEM GROUP LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ODEM GROUP LLC include <http://www.odemgroup.com> and OdemGroup. The OdemGroup website is a Technology Consultation site. By using the OdemGroup website, you consent to the data practices described in this statement.

Collection of your Personal Information

OdemGroup may collect personally identifiable information, such as your name. If you purchase OdemGroup's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by OdemGroup. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the OdemGroup website.

Use of your Personal Information

OdemGroup collects and uses your personal information to operate its website(s) and deliver the services you have requested.

OdemGroup may also use your personally identifiable information to inform you of other products or services available from OdemGroup and its affiliates. OdemGroup may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

OdemGroup does not sell, rent or lease its customer lists to third parties.

OdemGroup may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to OdemGroup, and they are required to maintain the confidentiality of your information.

OdemGroup may keep track of the websites and pages our users visit within OdemGroup, in order to determine what OdemGroup services are the most popular. This data is used to deliver customized content and advertising within OdemGroup to customers whose behavior indicates that they are interested in a particular subject area.

OdemGroup will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on OdemGroup or the site; (b) protect and defend the rights or property of OdemGroup; and, (c) act under exigent circumstances to protect the personal safety of users of OdemGroup, or the public.

Use of Cookies

The OdemGroup website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize OdemGroup pages, or register with OdemGroup site or services, a cookie helps OdemGroup to recall your specific information on subsequent visits.
